Submission Guidelines

Formatting your manuscript

- 1. The manuscript must not exceed 45 pages of plain paper (A4).
- The manuscript must have a title and a summary in both Arabic and English in one page; each summary should not be more than 200 words. The manuscript should include, in both languages, keywords that indicate the field of specialization. The keywords are written below each summary and should not be more than six.
- The author(s)' name(s), affiliation(s) and address must be written immediately below the title of the article, in both Arabic and English.
- Arabic manuscripts should be typed in Simplified Arabic, in 14-font size for the main text, and 12-font size for notes.
- 5. English manuscripts should be typed in Times New Roman, in 12- font size for the main text, and 9-font size for notes.
- The manuscript is to be typed on only one side of the sheet, and line spacing should be 1.5 cm. Margins should be 2.54 cm (or 1.00 inch) on all four sides of the page.
- 7. The manuscript must have the following organization:

Introduction

The introduction shows the topic and aims of the research paper. It should be consistent with the research ideas, information and the established facts. The research problem and its importance should be stated. In addition, a review of related literature should be introduced.

Body

The manuscript body includes all necessary and basic details of the research approach, tools and methods. All stated information should be arranged according to priority.

Findings and discussion

Research findings should be clear and brief, and the significance of these findings should be elucidated without repetition.

Conclusion

It is a brief summary of the research topic, findings, recommendations and suggestions.

 Figures, diagrams and illustrations should be included in the main text, in black and white, and consecutively

- numbered and given titles, and explanatory notes beneath them.
- 9. Tables should be also included in the main text, and consecutively numbered, and given titles and explanatory notes beneath them.
- Samples of scanned manuscripts must be included in the proper place of the manuscript.
- 11. The Journal of the North does not publish research and measurement tools (instruments). However, they must be included in the submissions for review by reviewers.
- 12. Documentation must follow the 6th edition of the American Psychological Association (APA) reference style in which both the author's name and year of publishing are mentioned in the main text, i.e. (name, year). Numbering the references inside the main text and adding footnotes is not allowed.
 - Researchers' documentation must be as follows: the author's family name followed by a comma and the publishing year like (Khayri, 1985).
 - Page numbers are mentioned in the main text in case of quotations, like (Khayri, 1985, p. 33).
 - If a work has two authors, they must be cited as shown previously, for

- example (Al-Qahtani & Al-Adnani, 1426H).
- If there are multiple (more than two) authors, their family names must be mentioned for the first time only, like (Zahran, Al-Shihri, & Al-Dusari, 1995); if the researcher is quoting the same work several times, the family name of the first author followed by "et al." [for papers in Engish], and by "وآخرون" [for papers in Arabic] must be used, like (Zahran et al., 1995) / (1995). Full publishing data must be mentioned in the bibliography.
- 13. Regarding Islamic studies and Arabic language studies it is permitted to number references and sources within the main text and add footnotes indicated by number or asterisk in 12-font size for Arabic and 9-font size for English.
- 14. Hadith documentation must follow the following example: (Sahih Al-Bukhari, vol.1, p.5, hadith number 511).
- 15. The bibliography, list of all the sources used in the process of researching, must be added in alphabetical order using the author's last name according to the APA reference style, in 12-font size for Arabic and 9-font size for English.
